PROCEDURAL HISTORY

On August 15, 2017, Grievant was issued a Group III Written Notice of disciplinary action with removal for client abuse.

On September 6, 2017, Grievant timely filed a grievance to challenge the Agency's action. The matter proceeded to hearing. On September 26, 2017, the Office of Equal Employment and Dispute Resolution assigned this appeal to the Hearing Officer. On October 30, 2017, a hearing was held at the Agency's office.

ISSUES

- 1. Whether Grievant engaged in the behavior described in the Written Notice?
- 2. Whether the behavior constituted misconduct?
- 3. Whether the Agency's discipline was consistent with law (e.g., free of unlawful discrimination) and policy (e.g., properly characterized as a Group I, II, or III offense)?

4. Whether there were mitigating circumstances justifying a reduction or removal of the disciplinary action, and if so, whether aggravating circumstances existed that would overcome the mitigating circumstances?

BURDEN OF PROOF

The burden of proof is on the Agency to show by a preponderance of the evidence that its disciplinary action against the Grievant was warranted and appropriate under the circumstances. The employee has the burden of raising and establishing any affirmative defenses to discipline and any evidence of mitigating circumstances related to discipline. Grievance Procedure Manual ("GPM") § 5.8. A preponderance of the evidence is evidence which shows that what is sought to be proved is more probable than not. GPM § 9.

FINDINGS OF FACT

After reviewing the evidence presented and observing the demeanor of each witness, the Hearing Officer makes the following findings of fact:

The Department of Behavioral Health and the Developmental Services employed Grievant as a Nursing Assistant at one of its Facilities. He had been employed by the Agency for approximately 5 years. No evidence of prior active disciplinary action was introduced during the hearing.

Grievant received training regarding Therapeutic Options of Virginia (TOVA). This training set forth the Agency's expectations for its employees regarding how they respond to physical conflict with patients.

On August 8, 2017, Grievant was working on the Unit with Patient A. He was in the shower room attempting to assist Patient A become ready for a shower. Patient A was speaking loudly. This drew the attention of Patient B. Patient B walked down the hallway to the shower room. Patient B began yelling and screaming at Grievant because she mistakenly believed Grievant was hurting Patient A. Grievant began pushing the lift out of the doorway into the hall. Patient B grabbed the lift and began pushing it back towards Grievant. Grievant angled his body sideways to move from one side of the lift to the side Patient B held. He used both hands to grab the wrists of Patient B. He crossed her wrists in front of her chest and moved her backwards as she fell to the ground. Grievant did not use a TOVA hold to move Patient B.

CONCLUSIONS OF POLICY

The Agency has a duty to the public to provide its clients with a safe and secure environment. It has zero tolerance for acts of abuse or neglect and these acts are punished severely. Departmental Instruction ("DI") 201 defines client abuse as:

This means any act or failure to act by an employee or other person responsible for the care of an individual in a Department facility that was performed or was failed to be performed knowingly, recklessly or intentionally, and that caused or might have caused physical or psychological harm, injury or death to a person receiving care or treatment for mental illness, mental retardation or substance abuse. Examples of abuse include, but are not limited to, acts such as:

- Rape, sexual assault, or other criminal sexual behavior
- Assault or battery
- Use of language that demeans, threatens, intimidates or humiliates the person;
- Misuse or misappropriation of the person's assets, goods or property
- Use of excessive force when placing a person in physical or mechanical restraint
- Use of physical or mechanical restraints on a person that is not in compliance with federal and state laws, regulations, and policies, professionally accepted standards of practice or the person's individual services plan; and
- Use of more restrictive or intensive services or denial of services to punish the person or that is not consistent with his individualized services plan.

For the Agency to meet its burden of proof in this case, it must show that (1) Grievant engaged in an act that he or she performed knowingly, recklessly, or intentionally and (2) Grievant's act caused or might have caused physical or psychological harm to the Client. It is not necessary for the Agency to show that Grievant intended to abuse a client – the Agency must only show that Grievant intended to take the action that caused the abuse. It is also not necessary for the Agency to prove a client has been injured by the employee's intentional act. All the Agency must show is that the Grievant might have caused physical or psychological harm to the client.

Client abuse is a Group III offense.² On August 8, 2017, Grievant grab the wrists of Patient B, crossed her arms in front of her, and moved her to the ground. Grievant did not use an approved TOVA technique to move Patient B. His actions might have caused physical or psychological harm to the client. The Agency has presented

sufficient evidence to support the issuance of a Group III Written Notice for client abuse. Upon the issuance of a Group III Written Notice, an agency may remove an employee. Accordingly, Grievant's removal must be upheld.

Grievant argued that the disciplinary action was excessive given that he was attempting to stop Patient B from interfering with his work duties assisting Patient A. The evidence showed, however, that Grievant could have accomplished his objective by using a TOVA technique without placing Patient B at risk of injury.

Grievant argued that the Facility's staffing levels were inadequate. Grievant was disciplined for failing to use an approved TOVA technique in response to Patient B's behavior. The Facility's level of staffing had no effect on his decision regarding how to respond to Patient B's interference with his duties.

Va. Code § 2.2-3005.1 authorizes Hearing Officers to order appropriate remedies including "mitigation or reduction of the agency disciplinary action." Mitigation must be "in accordance with rules established by the Department of Human Resource Management" Under the Rules for Conducting Grievance Hearings, "[a] hearing officer must give deference to the agency's consideration and assessment of any mitigating and aggravating circumstances. Thus, a hearing officer may mitigate the agency's discipline only if, under the record evidence, the agency's discipline exceeds the limits of reasonableness. If the hearing officer mitigates the agency's discipline, the hearing officer shall state in the hearing decision the basis for mitigation." A non-exclusive list of examples includes whether (1) the employee received adequate notice of the existence of the rule that the employee is accused of violating, (2) the agency has consistently applied disciplinary action among similarly situated employees, and (3) the disciplinary action was free of improper motive. In light of this standard, the Hearing Officer finds no mitigating circumstances exist to reduce the disciplinary action.

DECISION

For the reasons stated herein, the Agency's issuance to the Grievant of a Group III Written Notice of disciplinary action with removal is **upheld**.

APPEAL RIGHTS

You may request an <u>administrative review</u> by EEDR within **15 calendar** days from the date the decision was issued. Your request must be in writing and must be **received** by EEDR within 15 calendar days of the date the decision was issued.

You must also provide a copy of your appeal to the other party and the hearing officer. The hearing officer's **decision becomes final** when the 15-calendar day period has expired, or when requests for administrative review have been decided.

A challenge that the hearing decision is inconsistent with state or agency policy must refer to a particular mandate in state or agency policy with which the hearing decision is not in compliance. A challenge that the hearing decision is not in compliance with the grievance procedure, or a request to present newly discovered evidence, must refer to a specific requirement of the grievance procedure with which the hearing decision is not in compliance.

You may request a <u>judicial review</u> if you believe the decision is contradictory to law. You must file a notice of appeal with the clerk of the circuit court in the jurisdiction in which the grievance arose within **30 days** of the date when the decision becomes final.^[1]
